Payment Terms

Payment of either the full fee or deposit plus first instalment is required at the point of enrolment to secure a place. Places on a course cannot be held without payment.

Early Bird discount fees are only available for payment in full at time of enrolment.

Monthly instalments must be paid by Automatic Payment and received by 10th of each month.

The flexible monthly payment plans are not a “pay as you go” option. Payments are for 8 consecutive months regardless of attendance.

Cancellation & Refund Policy

Fees once paid are non-refundable. If you are unable to attend a booked course, you can transfer onto any future NZSPH course within the next 3 years. Any request to cancel and transfer a course must be made in writing.

If you are in any doubt about your suitability for or commitment to the full Diploma course, it is recommended that you begin with the 3 Day Introduction to Hypnosis course to make sure the course is right for you.

Missed days or weekends can be made up on future courses and at any training location.

NZSPH reserves the right to cancel or reschedule training days or weekends if necessary. In the unlikely event that this happens, NZSPH will reimburse any reasonable, non-refundable expenses incurred by participants as a result of cancellation against receipts.
